Eligibility requirements for Oklahoma Tribal VR programs:

- Must be a member of a federally recognized tribe.
- Must have a documented physical or mental disability that creates an impediment to employment.
- Must live within the tribal VR service area.
- Must be able to benefit from VR services in terms of employment outcomes and must require VR services to prepare for, enter, or retain suitable employment.




